Austrian online betting brand

bwin Interactive Entertainment AG, formerly known as Betandwin, is an Austrian online betting brand acquired by Entain PLC. The group operated under international and regional licences in countries like Gibraltar, the Amerindian reserve of Kahnawake (Canada), and Belize; and Germany, Italy, Mexico, Croatia, Austria, France,[2] and the United Kingdom in Europe. Bwin offered sports betting, poker, casino games, and soft and skill games, with most revenue coming from poker and sports betting. bwin had over 20 million registered customers in more than 25 core markets. Competence centres were located in Vienna, Stockholm, and Gibraltar.[3]

The company provided services for its subsidiaries such as marketing, finance, and administration, corporate communications, controlling, and IT services. All operational activities were managed by licensed subsidiaries. It was listed on the Vienna Stock Exchange from March 2000 until the company's merger with PartyGaming plc in March 2011, forming Bwin.Party Digital Entertainment. That company was purchased by GVC Holdings in February 2024; GVC continues to use bwin as a brand.

History [edit]

Beginning with 12 employees in its founding in 1997, bwin was formerly known as "betandwin" until 2006. The company launched its first online gambling site in 1998, focusing on the growing sports betting market. One of the most important developments in the company's history was the launch of its live betting product, developed in-house, allowing players to place bets on sporting events while the actual event was taking place. The firm's initial public offering at the Austrian Stock Exchange took place in March 2000.

Betandwin acquired Simon Bold (Gibraltar) in June 2001 and changed its name to bwin International Ltd. This relocation to Gibraltar was done to keep up with the company's main competitors, who had already moved to the British Overseas Territory.

By December 2001, betandwin was ready to step into the online casino gaming market and did so

by launching its first casino platform. Two years later, in July 2003, betandwin introduced and launched a soft games platform known as "Balls of Fire".

In November 2004, betandwin launched multiplayer poker. In June 2005, the group acquired betoto, a company which offers a fixed-odds betting service to punters around the globe, in an effort to expand its presence in the Greek market.

In December 2005, betandwin acquired Ogame e-Solutions AB, a move consistent with the group's strategy to expand into the poker market. After the takeover, Ogame e-Solutions changed its name to bwin Games. In 2005, betandwin acquired global media rights outside of Germany to the Germany Football League.

In August 2006, betandwin launched the new bwin brand. This was done after it was found that the betandwin brand, which was described as "descriptive, high-grade and functional", was not suited anymore for the wide assortment of entertainment offerings covered by the company, including sports betting, poker, soft games, and casino games.

In 2007, bwin began to offer live streaming of major sports events.

In September 2009, bwin announced the acquisition of Italian poker operator Gioco Digitale, marking the company's entry into the Italian online gambling market.[4][5]

Bwin is often confused with BetWinner, but they are different bookmakers, with individual features and advantages.[6]

PartyGaming merger [edit]

On April 1, 2011, bwin and British gaming firm PartyGaming announced their merger. The new company bwin.party became the world's largest publicly traded online gaming firm, 48.4% of which was owned by existing PartyGaming shareholders and 51.6% by bwin shareholders. The merged company was listed on the London Stock Exchange, with joint CEO's Norbert Teufelberger and Jim Ryan.[7] After a takeover of bwin.party by British GVC Group, the brand bwin continues to exist as customer brand in its portfolio.

Products [edit]

The company's subsidiaries and affiliated companies offer sports betting, poker, casino games, and soft games, as well as audio and video streams on sporting events, such as the German Bundesliga. These are all provided via the Internet, and many are also available via other digital distribution channels, such as mobile phone.

Sports Betting [edit]

Sports bets are the core business at bwin. Today, the sports betting line-up includes more than 90 different sports; the core area of customer interest is soccer. Other sports include all popular ball-related sports, US sports, as well as all major winter sports and motorsports ranging from Formula 1 to MotoGP. "Exotic" sports such as Roller Hockey, Futsal, and Darts are also included in the daily line-up. Customers can also find odds on a range of events outside the area of sports. These include bets on politics and entertainment, such as the Oscars, Talent Shows, the Eurovision Song Contest, and "Miss" events.[8]

Poker [edit]

The following types of games are offered at bwin Poker: Texas Hold'em, Omaha, Omaha Hi/Lo, Seven Card Stud, Seven Card Stud Hi/Lo, and Five-card draw. In terms of stakes, users can choose between Fixed Limit, Pot Limit, or No Limit tables. A "play money" version of the games is also available for users to try for free. bwin offers poker tournaments, including Sit & Go, scheduled, and cash games (ring games). Sit & Go tournaments begin as soon as the table is completely occupied. Scheduled tournaments begin at a specified time and allow for a higher numbers of participants and the highest prize pools. In cash games the players can join and leave at-will. bwin Poker can be played using the Mac OS X Poker Client, the Windows Poker Client, the Java Poker Client, or the Mobile Poker Client. The Mac and Windows versions offer an extensive selection of features such as statistics and a mini-table function. The Java client is platform-agnostic and browser-based. The mobile client allows customers to play cash games on their mobile phones.[9]

Casino Games [edit]

bwin offers more than 1000+ games, ranging from classics such as roulette or blackjack to slot

machines and casino tournaments. The casino has a longstanding tradition at bwin, but in 2001, it was introduced as a second product, in addition to sports betting.[10]

Soft Games [edit]

bwin offers more than 60 games divided into the categories of Fortune Games, Skill Games, Mini Games and "ParaDice", as well as Backgammon. This is the product group with the biggest potential for innovation and expansion in the market.[11]

bwin Games AB [edit]

bwin Games AB – founded in 1999 and formerly known as Ogame e-solutions AB – became part of the bwin Group following its acquisition, in March 2006, by bwin Interactive Entertainment AG. Within the bwin Group, bwin Games AB acts as the competence centre for poker and casino games, developing products via digital distribution channels for bwin's proprietary owned brands, such as PokerRoom, HoldemPoker, eCardroom, PokerGaming, Europoker, and the Ogame Network partners.

PokerRoom was an online poker cardroom founded in 1999. Licensed by the Kahnawake Gaming Commission, PokerRoom offered both play and real money formats. Tournaments and ring games were available in both web-browser and download client platforms, with support for both Macintosh and Linux. PokerRoom was one of the first online poker sites to provide multi-language support, and catered to Danish, German, Spanish, French, Italian, Russian, and Swedish speakers. These languages were accessed via "regional sites", many of them showing local sponsorships for the selected region.

Legal Issues [edit]

PokerRoom also maintains a play money only site, PokerRoom.tv, that is advertised in Canada on the boards of National Hockey League rinks, as well as on U.S. television networks like ABC.

Awards [edit]

PokerRoom has won industry awards, such as "Poker Site of the Year" from the UK Gambling Awards in 2006 and "Top Poker Software" from the Online Gambling Magazine Awards in 2005.

Shutdown [edit]

After 10 years of operation, bwin announced the closure of PokerRoom on April 14, 2009. Players with money still left in their accounts were encouraged to transfer their balance and play at bwin.[12] However, PokerRoom players with large "play money" accounts had to abandon those accounts when transferring to bwin.

Legal Status [edit]

As the global legal framework for Internet gambling is a complicated mix of laws and regulations, bwin's situation varies depending on the country concerned. For several years now, the United Kingdom and Italy have been examples of countries that have regulated their online gaming markets to the advantage of all stakeholders. Just recently, Italy extended its online licenses to include poker tournaments, and countries like France, Spain, and Denmark announced their intention to permit private operators access to their markets under stringent conditions and controls. Other countries, on the other hand, are still pursuing a policy of maintaining a state monopoly of internet gaming, or even a complete ban.

On 15 September 2006, Norbert Teufelberger and Manfred Bodner were arrested[13] at a press conference in La Turbie, France, due to offenses against the French gambling laws. After an investigation the judge released them on the evening of September 18, 2006.

Due to the enactment of the Safe Port Act, bwin stopped taking bets from United States-based players in October 2006.[14] The offerings became available again upon regulation of the markets. In the States where regulation is in place, the same product line offered through bwin is available through BetMGM, the joint venture of bwin's parent company Entain PLC's with MGM Resorts International.

On 6 March 2007, the European Court of Justice struck down Italian national gambling restrictions in the Placanica case.[15]

The EFTA Court held hearings in January 2007 to decide on the admissibility of a state monopoly for betting and gaming according to European Law. The decision of the EFTA Court will be made on 14 March 2007.[citation needed]

In February 2024, bwin ended its operations in Russia. An agreement was made with Parimatch enabling customers to transfer platforms along with their funds.[16]

bwin sponsored football giant Real Madrid from 2007 to 2013 and they were also a premium partner of FC Bayern Munich. In October 2010, bwin announced a sponsorship for the upcoming three football seasons in which they would be the title sponsor of the Portuguese League Cup (renamed the "bwin Cup").[17] In July 2010, bwin signed a two-year sponsorship deal with Italy's second tier, Serie B. Additionally, bwin cooperates with the International Basketball Association (FIBA) and has been sponsoring the European and World Basketball Championships since 2006. In the area of motorsport, the company is one of the main sponsors of the MotoGP series. In 2010, bwin became the title sponsor of the races in Jerez and Estoril and official partner of the GP in Brno, Misano, Mugello. In the past, many other popular events across international and local sports were supported by bwin. bwin also lent its name to the Primeira Liga (bwinLIGA), sponsored Italian football club Milan from 2006 to 2010, and has also been a partner to popular football clubs, such as Real Madrid, Juventus and Werder Bremen.[18]

In addition, bwin organised numerous online and offline poker events. One of the biggest regular online poker tournaments was the ChampionChip. Special poker tournaments, like the Weekly Country Showdown or the bwin Dailies, offered a huge range of tournaments adjusted to specific country regulations and buy-in levels. Periodically new types and variations of Sit & Go tournaments were launched. Through several online qualifying events, a bwin user could qualify for offline events like the World Series of Poker (WSOP), the Aussie Millions, and events on the World Poker Tour. For "poker newbies", bwin offered a special route - the Rookie Challenge, where a new poker player had the chance to climb up several stages for free to earn real money tickets.

In 2008, bwin provided the luxury villa on bwin PokerIsland[19] as filming location for the music video of Lady Gaga's hit Poker Face. The video featured bwin branded poker equipment through a product placement campaign.[20]

The company faced some opposition in Europe over its sponsorship of sports, especially football. In 2006, Bremen banned its top football team, Sportverein Werder Bremen, from carrying the bwin logo on its shirts.[21] In November 2009, the city acted further by moving against sport stores which sold shirts from other teams, such as Milan and Real Madrid.[citation needed]

In 2024, bwin signed a three-year partnership with Italian football club Inter Milan becoming its first official betting partner.[22]

In 2024, bwin became Valencia CF's main global sponsor. The three-year agreement was made official in July 2024.[23] As of 2024 the agreement is in jeopardy with the Spanish government informing all La Liga clubs that betting sponsors will be banned from the start of the 2024-22 season.[24]

In 2024, bwin announced a three-year partnership with the Belgian Pro League becoming the official sports betting partner of Belgium's top tier football division.[25] The deal will also cover the Belgian First Division B and Belgian Super Cup. bwin is able to broadcast live coverage of football matches to customers using both online and mobile platforms as part of the agreement.

In April 2024, bwin signed a five-year partnership with Liga Portugal. As part of the deal, the Primeira Liga, Portugal's top football division, will be called Liga Portugal Bwin from July 2024 onward.[26]

In August 2024, bwin signed extended deals with German Bundesliga football clubs Borussia Dortmund, Union Berlin, and FC Köln, as well as 2. Bundesliga clubs FC St. Pauli and Dynamo Dresden.[27] As part of the deal, bwin will serve as the exclusive sports betting provider for each team. Each of the agreements will run from the 2024-22 season until the end of the 2024-24 season.

In September 2024, bwin signed a partnership with UEFA to become an Official Partner of the UEFA Europa League and the UEFA Europa Conference League for the 2024–24 seasons.[28] Responsible Gaming [edit]

A dedicated Corporate Social Responsibility department of the company was in charge of social responsibility. Protection of minors, protection against manipulation of bets, and the prevention of

gaming addiction were key aspects of the bwin CSR philosophy. bwin supported research in this field in a joint project with Harvard Medical School. bwin is a co-founder of the EGBA (European Gaming and Betting Association), where it lobbied for fair competition within a regulated online gaming market. As founder and member of the ESSA (European Sports Security Association), bwin campaigned against manipulation and fraud in the fields of sports and betting.[29]

Awards [edit]

At the annual EGR Awards organised by eGaming Review magazine, bwin won the "Operator of the Year 2009" award.[30]

A probabilidade de uma casa da aposta como a bwin "pagar mesmo" é um assunto comum entre os usuários. Em geral, a bwin é considerada uma empresa confiável e licenciada - o que significa também eles precisam cumprir determinadas normas e padrões para manter a licença. Isso inclui o pagamento por ganhos justos ou o cumprimento das todas as leis/regulamento-relevantes!

Em relação às suas ofertas de aposta desportiva, a bwin geralmente paga as vencedoras sem problemas. No entanto também é importante notar que há algumas coisas que podem levar ao atraso no pagamento ou mesmo à perda de uma jogada: Isso pode incluir resultados imprecisos em jogos (parcerias inválidas), arriscadas acima do limite ou ainda violações das regras na casa com probabilidade

Além disso, é essencial lembrar-se de que as apostas desportivas estão sujeitas a uma certa quantidade de risco e incerteza. Mesmo algumas das melhores casas de apostas - como a bwin também não podem garantir com você sempre ganhe dinheiro! Dito isto: É sempre recomendável arriscar somente o quanto se pode permitir - Se perder ou nunca confiar Com recurso (é necessário para outras despesas).

Em resumo, a bwin é uma casa de apostas confiável que geralmente paga as suas devidas vencedoras. No entanto também é importante estar ciente dos termos e condições da casa de apostas e os riscos inerentes às apostas desportivas!

Em fevereiro de 2012 foi anunciado o retorno de Michael "Michael" Walsh, um ex-jogador de futebol escocês que passou parte do ano nos treinamentos para a equipe de Manchester City onde se revelou como o substituto de Michael "Sly" McAlpine no lugar de Gareth Murdoch. Walsh revelou à revista "Q Magazine" que esperava ser anunciado como sucessor de Gareth Murdoch, mas foi informado apenas após a derrota de 2 a 1 para o Liverpool pela Copa da Inglaterra em setembro; após a vitória do Liverpool, Walsh foi demitido, sem obter nenhuma das suas funções após a divulgação de seu novo contrato.

Walsh se saiu do clube em março e nunca mais voltou.

Em maio de 2015, foi noticiado que o ex-assistente do clube Jack Charlton teria sido contratado como treinador do Manchester City.

A decisão da Suprema Corte de Israel na terça-feira que encerrou uma isenção para judeus ultraortodoxos servirem nas forças armadas do país poderia anunciar mudanças sísmicas no caminho, com implicações sociais e políticas.

A decisão provavelmente vai sobrecarregar ainda mais a frágil coalizão de governo do primeiro-ministro Benjamin Netanyahu, que depende da ajuda dos dois partidos ultraortodoxos para apoiarem essa isenção.

A questão da isenção ultraortodoxa polarizou há muito tempo um país onde a maioria dos judeus de 18 anos, homens e mulheres são recrutados por muitos meses para prestar serviços obrigatório. Os israelenses tradicionais se queixam durante bastante mais do que uma falta na

igualdade entre os dois países?!

Mais recentemente, a guerra de meses em Gaza e conflitos iminentes noutras frentes têm sublinhado as necessidades militares para mais soldados.

Quem são os Haredim?

Muitos dos ultra-ortodoxos de Israel - conhecidos em hebraico como Haredim, ou aqueles que temem a Deus – oferecem ao Estado apenas reconhecimento real e rejeitando o conceito da soberania secular judaica.

Em vez disso, muitos Haredim vêem o estudo da Torá em tempo integral como um valor supremo e argumentam que esta bolsa de estudos garantiu a sobrevivência do povo judeu por séculos.

Mas a minoria ultra-ortodoxa em Israel está longe de ser homogênea, com os seguidores dos tribunais rabínicos mais insulares e protetores do status especial da comunidade que outros.

Alguns Haredim escolheram se juntar aos militares ao longo dos anos, buscar uma educação superior secular e tornar-se mais parte da sociedade israelense em geral.

Mas outros Haredim mais hard-core temem a imagem dos militares como um caldeirão e dizem que os jovens homens, indo para o exército de ultraortodoxos saem seculares. Mulheres Ultra Orthodox não servem!

Os Haredim compõem cerca de 13% da população israelense. Mas é uma comunidade jovem que favorece famílias grandes, e como resultado seus membros formam um número cada vez maior do país em idade de coorte draft-age (em idade).

Atualmente, uma média anual de cerca de 1.200 Haredim servem no exército em uma pequena fração do posto e arquivo. E muitos deles são considerados pela comunidade como sendo abandono religioso ou provenientes das margens da sociedade dos Haredim (Haredi).

O que está em jogo?

Logo após a fundação de Israel em 1948, o primeiro-ministro do país David Ben Gurion isentou 400 yeshiva ou seminário religioso estudantes dos serviços militares e concordou com isenções futuras como parte dum acordo para conceder aos ultraortodoxos uma medida de autonomia na troca pelo seu apoio à criação de um estado amplamente secular.

As primeiras isenções foram destinadas, entre outras coisas para ajudar a restaurar as fileiras de bolsa Torá depois que eles eram dizimados no Holocausto. Historiadores dizem que Sr Ben-Gurion acreditava que Israel moderno ultra Ortodoxia iria diminuir ou eventualmente desaparecer ”.

Em vez disso, os Haredim tornaram-se a parte que mais cresce da população de Israel e levaram muitos especialistas israelenses à conclusão de que o modelo das isenções em massa não é sustentável. O ressentimento cresceu entre grandes segmentos dos cidadãos israelitas sobre o que eles consideram uma partilha desigual do fardo nacional ”.

Depois de décadas legais e anos de procrastinação governamental, a questão agora chegou ao fim. Com todas as leis temporárias que expiraram hoje em dia o tribunal decidiu não ter base legal para uma isenção militar duradoura

Além de dividir o país, a questão tem potencial para colapsar a coalizão do governo Netanyahu em meio à guerra custosa na Faixa.

Netanyahu deve agora se esforçar para encontrar uma solução legislativa aceitável aos partidos ultraortodoxos, que apoiam a isenção e seus aliados mais laicos ou nacionalistas ao contrário à lei. A decisão leva Israel a "novo território" e constitui um precedente para política israelense, sociedade israelita ou exército", disse Shuki Friedman vice-presidente do Instituto de Política Popular Judaica independente com sede em Jerusalém.

Se a discussão até agora sempre foi sobre igualdade, disse ele. o foco mudou para necessidade de mais soldados e os ultra-ortodoxos são "uma fonte importante do potencial de recrutamento".

O que acontece a seguir?

Logo após a decisão de terça-feira, o escritório do procurador geral israelense Gali Baharav Miará enviou instruções aos funcionários governamentais pedindo que implementassem imediatamente a sentença.

A carta dizia que o estabelecimento de segurança já havia se comprometido a elaborar mais 3.000 estudantes ultraortodoxos do seminário no próximo ano. Mas não ficou imediatamente claro quando ou como os militares escolheriam esses recrutadores dos 60 mil alunos casim 1win idade avançada atualmente matriculados nos seminários religiosos com isenções ao serviço "Este é um número inicial para recrutamento imediato que não reflete totalmente as necessidades atuais dos militares e o avanço de uma partilha igual do fardo", a carta estipulada, pedindo às autoridades criarem planos mais abrangentes.

O partido Likud, de Netanyahu perante o governo israelense e a oposição do presidente dos EUA disse que vai avançar com uma legislação para pedir pequenos aumentos no recrutamento Haredi mas codificaria casim 1win grande parte as isenções da maioria das outras.

O projeto de lei pode não obter a aprovação do Parlamento casim 1win casim 1win forma atual, enquanto qualquer endurecimento dos termos poderia perturbar os rabinos e as partes Haredi das quais o Sr. Netanyahu depende".

Por enquanto, o Sr. Netanyahu provavelmente jogará por tempo e os partidos Haredi não têm muito interesse casim 1win derrubar a administração do governo que é mais direitista na história de Israel ou religiosamente conservadora da nação árabe sionista (ver abaixo).

Mas a decisão judicial, disse Israel Cohen um proeminente comentarista Haredi com Kol Berama (uma estação de rádio ultra-ortodoxa), certamente criou uma "dinâmica negativa" para o governo.

Como as atitudes dos Haredim estão mudando?

Desde o ataque liderado pelo Hamas contra Israel casim 1win 7 de outubro, que levou à guerra na Faixa da Gaza há uma maior prontidão para servir.

Após o ataque, milhares de Haredim expressaram disposição para se juntar aos militares.

Muitos jovens Haredim querem cada vez mais participar do exército, ensino superior e da força de trabalho", disse Yitzik Crombie. um empresário ultra-ortodoxo que executa vários programas para ajudar os membros das comunidades a se integrarem nessas áreas."

"Mas eles têm muito medo", disse ele, de perder casim 1win identidade especial e cultura. Ser um Haredi é estar separado da outra sociedade."

Juntar-se ao exército significa trocar o uniforme de assinatura casim 1win preto e branco dos alunos do seminário por fadigas cáqui, mudando a lealdade entre um rabino para comandante. Os militares devem construir confiança na comunidade mostrando como os recrutadores podem servir ou permanecer Haredi

Muitos Haredim inscritos casim 1win seminários não estudam o dia todo, se é que estudaram.

Desde 7 de outubro do ano passado Cohen disse: "Mais pessoas estão adotando a posição segundo qual quem quer seja incapaz pode entrar para as Forças Armadas".

Mas mesmo que as atitudes casim 1win relação ao serviço estejam mudando, outras permanecem veementemente opostas à conscrição.

Alguns rabinos atacaram a decisão do tribunal por não colocar valor na importância de estudar Torá, disse Cohen.

O rabino Moshe Maya, que é intimamente afiliado ao partido ultra-ortodoxo Sha'S partidário do presidente Netanyahu e parceiro chave da coalizão de Israel com o líder israelense Benjamin Hussein (o primeiro), disse a Kol Berama na quarta feira (19) "um filho dos Torá está proibido para se alistar".

"Aqueles que vão ao exército hoje saem como profanadores do sábado", acrescentou.
